SECTION 6: Accidental Release Measures

6.1. Personal Precautions, Protective Equipment and Emergency Procedures

Wear protective gloves and eye protection.

6.2. Cleanup and Containment Methods and Materials

Ventilate area of leak or spill. Cover spill with a 1:1:1 mixture by weight of Sodium Carbonate or Calcium Carbonate, clay and sand. Scoop mixture into a plastic container and, in the fume hood, add to a pail of cold water. Neutralize this mixture with 5% Hydrochloric Acid, let stand overnight, then pour the liquid into the drain while flushing with water. Dispose of any solid with normal refuse. Wash the area of the spill with plenty of water.

SECTION 7: Handling and Storage

7.1. Precautions for Safe Handling and Storage Conditions

Store in corrosive resistant container with a resistant inner liner. As with all chemicals, wash hands thoroughly after handling. Avoid contact with eyes and skin. Protect from freezing and physical damage. Store below 25°C. Empty containers may be hazardous since they retain product residues.

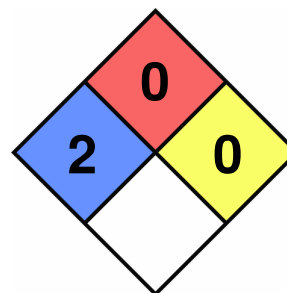
