4.1. General First Aid Information

SECTION 5: Fire-Fighting Measures

5.1. Extinguishing Media

Flammable liquid and vapor. Moderate explosion hazard and dangerous fire hazard when exposed to heat, sparks and open flames. Above flash point, vapor-air mixtures are explosive within flammable limits noted above. Sensitive to static discharge.
